

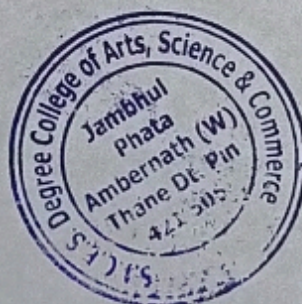
BLOOD DONATION CAMP PROGRAM REPORT




REPORT ON PULSE POLIO IMMUNIZATION PROGRAM

10. Moreover Ambernath Municipal Corporation had provided the refreshment of 600 boxes to the participants.




REPORT ON "KOLHAPUR RELIEF FUND"

The name of the Trust shall be "THE YUVA UNITY FOUNDATION"


3. PLACE

The principal office of the Trust shall be situated at S. N. 14/8, Mahendra Nagar, Jawsai Village, Ambernath (W) – 421501, Dist. Thane, Maharashtra State (India) or such other place as the Trustees may from time to time decide. The Trust may also carry on its work at any other place or places, as decided by the Trustee.

4. OBJECTS

1. To run, maintain, or acquire educational or other institution for coaching, guidance, counseling or vocational training or to grant scholarship to poor, deserving and needy students for elementary and higher education.




6. To provide financial assistance to the poor, underprivileged or affected people for medical treatment, professional or spiritual studies, construction of housing tenements or community hall, religious tour, marital ceremonial activities, legal assistance in case of unproven crime, etc.
7. To run, manage, organize & administer homes or welfare centers for destitute, homeless, orphans, underprivileged, senior citizens & wandering or disgrace peoples.
8. To utilize fund to promote welfare schemes for the affected women and to provide financial help to widows, illiterate, unemployed, wondering & crime affected women.
9. To run, manage & administer commercial venture for employment of women or creates organizational setup for group of women who want to engage themselves in self-employment projects.
10. To provide financial assistance for marriages of underprivileged peoples or to build infrastructure for conducting mass marriage functions of community marriages and to provide financial package to poor couples for meeting pre & post marriage expenses.
11. To allocate funds for providing basic amenities to the public like building toilets, bathrooms & rest rooms in public places including construction of small concrete passages/roads & drainage canals in slum areas or in general public utility places.

14. To undertake any other activity incidental to the above activities but which are not inconsistent with the above objects.

5. BENEFICIARIES OF THE TRUST:

The Trust is established for the benefit of citizens of India and the class of people mentioned above without discrimination of caste, religion, creed or sex.

6. NUMBER OF TRUSTEES:

The number of Trustees including the Author of the Trustees shall not be less than 05 and not more than 15 persons. The Board of Trustees shall nominate and invite person/persons to be other trustees for such period, as they may deem fit and proper.

7. TERM OF OFFICE OF THE TRUSTEES:

The Trustees shall hold office for such duration as may be specified by the board of trustees. *The Trustees shall hold office for period of five years*

8. PRESIDENT:

There shall be a president for the administration of this trust, nominated by the board of Trustees, who shall be one amongst trustees as specified in Para (4) above for such period, in such manner as may be specified in this behalf.

The President shall discharge the duties of the Managing Trustee, in the absence of the Managing Trustee of the Trust and shall have the power and authority delegated and assigned to him/her by the Managing Trustee.

9. SECRETARY:

The Secretary shall maintain the records of the organization prepare and circulate agenda and minutes of Board of Trustee meeting for the approval of the Managing Trustee.

The Secretary shall be also responsible for the day to day administration activities of the Trust. 10. TREASURER:

14. MEETING OF TRUSTEES

Regular meetings of the Trustees may be held at such time and place as shall be determined, from time to time, by the trustees themselves, but at least two such meetings shall be held in three months. Notice of regular meetings of the Trust shall be given to the Trustees, personally or by mail, or telegraph, at least three days prior to the day on such meetings are to be held. The minutes of the said meetings shall be recorded in minute's book for official record of the trust management. In case of any difference between the trustees with respect to particular subject matter, the opinion of the majority shall prevail and bind on all trustees, board of managers & beneficiaries in general.

15. QUORUM OF THE MEETING OF TRUSTEES

In all meeting of the trustees, one third of the total strength of the trustees shall constitute a quorum for the transaction of business. If at any meeting of the trustees, if the strength is less than the minimum required quorum, the majority of those present may adjourn the meeting to later hour of the same day and the same place as may have been specified in the notice or calling it to a subsequent date, not earlier than 7 days and not later than 15 days and at any such adjourned meeting, the business on the agenda of original meeting shall be transacted whether there is quorum or not.

16. VOTING:

Decisions of the Board of Trustees may be made at a meeting or by circulation of papers to them. Normal matters of routine nature may be circulated and decision obtained. 14. POWERS, FUNCTIONS AND DUTIES OF THE TRUSTEES:

(a) All property of the Trust Movable or Immovable or of any other kind, shall vest in trust, the trustees shall manage the whole property and affairs of the trust and shall have all powers, duties and functions necessary proper and incidental to the promotion and carrying out of the objects of the trust.

- vi. (a) To enter into contracts, or engagements on behalf of the Trust.

- xi. To appoint such employees on such terms and conditions as the Trustees may deem fit for carrying out the work of the trust and exercise control all such employees including the power of suspension, dismissal and removal.
- xii. To delegate to the Managing Trustee or any appointed committee such powers, duties and functions as are vested in the Trustees.
- xiii. To frame Bye-Laws and such other regulations as are required for achieving its objectives.
- xiv. Out of the income of the trust property the trustee shall be entitled to spend or incur the following expenses namely
- (a) All rates, taxes, cess, assessments, dues and duties if any payable to the government to any municipal or other public bodies in respect thereof or any part thereof.
- (b) The premium for the insurance of the buildings or any other insurable property movable or immovable for the time being forming part of the trust property.
- (c) The costs of ordinary repairs and for providing any amenities to the buildings for the time being forming part of the trust property.
- (d) The cost of making such additions/alterations or improvements to or in the buildings forming part of the trust property, as the trustees shall think fit.
- (e) Wages and salaries of any manager, supervisor, accountant, clerk, servant or other employees employed by the trustees in the carrying out of this trust.
- (f) Cost and expenses of keeping the trust property in good condition.
- (g) Cost and expenses for installing and renovating the electrical and other installations in the building for the time being forming part of the trust property.

(h) The architect's fee and legal charges and fee payable to other professionals engaged in the course of administration of the trust.

(i) All other costs, charges and expenses of and incidental to the management and administration of the trust property in accordance with the objects and purposes hereof or which may be incidental thereto. After deducting the costs charges and expenses incurred by the trustee's as aforesaid out of the total gross income received by them from the trust property the balance that is the net income will be utilized for the objects of the trust as decided by the board of trustees.

15. STRENGTH, PRIVILEGES, RESPONSIBILITIES, RETIREMENT & APPOINTMENT OF TRUSTEES

1. The number of trustees shall not be less than three but not more than fifteen.
2. The trustees shall elect the board of office bearers with appropriate strength decided by majority of vote and elected office bearers shall constitute office of the president, vice-president, secretary & treasurers, upon whom the responsibility shall be entrusted for management of day today affairs of the trust.
3. In case of any difference between the trustees, the opinion of the majority shall prevail.
4. Every trustee shall be at liberty to nominate or appoint attorneys or agents and to delegate all or any of the duties and powers vested in him to such attorney or agent, and to remove such attorney or agent and reappoint other or others in his place.
5. No trustee shall be held responsible or liable for any loss or any act of omission or commission by his constituted attorney or agent or employees or other trustees unless occasioned by his willful neglect or default.
6. Any of the trustees may retire on giving one month's notice in writing to the other trustee (s).
7. If any trustees dies, retires, or become incapable or unfit to act, the continuing or surviving trustee or trustees shall appoint a successor in the place of such trustee.
8. If at any time the number of the trustees is less than three, the existing trustee shall appoint one or more trustees to meet the minimum requirement for management of the trust.

9. Upon the appointment of new trustee, the trust properties shall vest in the new trustee jointly with the continuing or surviving trustees, with duties and power of the trustees set out hereinabove in this deed.

10. If the majority of trustees found some of trustees unreliable or their trusteeship may cause harm to the object of the trust or undermine credibility or doctrine of the trust, in such cases the trustees shall terminate trusteeship of all those trustees by majority of votes but before doing so the trustees against whom the action have to be taken shall be given an opportunity of being heard and their argument shall be recorded while initiating the process of termination and no such termination shall stand valid unless it is approved by the charity commissioner or any other officer of the said designation.

11. If the trust is determined by efflux of time, the corpus of the trust shall be divided amongst the beneficiaries in the shares as fixed by the trustees.

6. REMOVAL OF OFFICE BEARERS

At any regular or special meeting duly called by the trustees may remove any one or more of the managers with or without cause by a majority of the trustees and a successor may then and there be elected to fill the vacancy thus created. Any manager of the board, whose removal has been proposed by the trustees, shall be given an opportunity to be heard at the said meeting.

16. FUNDS

The Trustees may accept donations, grants, subscriptions, aids or contributions from any person, government, foreign aid agency/forum, local authorities or any other charitable institutions, in cash or in kind including immovable property without any encumbrance, but the Trustees shall not accept any favour with such conditions or terms inconsistent with the objects of the Trusts.

While applying such receipts to the objects, the Trustees shall respect the directions, if any, by the granter. Any receipt with specific direction to treat the same as part of the corpus of the Trust or separate fund shall be funded accordingly.

17. INVESTMENT

1. All monies, which shall not immediately required for current needs shall be invested in eligible securities and investments, or in banks and all such investments shall be in the name of Trust.

2. That the trustees shall invest the trust funds, carry on any business with the trust funds and/or enter into partnership on behalf of the trust, as they may deem fit.
3. That the Trustees shall manage the trust funds and investments thereof as a prudent man would do the same. They shall recover all outstanding and meet all recurring and other expenses incurred in the upkeep or management thereof.
4. That the Trustees shall receive and hold the income of the trust on behalf and for the benefit of the beneficiaries under the trust.



BANK ACCOUNT

All income, subscription and pecuniary donations for general purposes of the Trust and the income, investments and all other moneys from time to time forming the part of general revenue of the Trust shall be deposited into a bank account with any scheduled bank in which trust normally operates its account for accomplishment of object of the trust. The bank accounts shall be operated jointly by any three members of the board.

8. ACCOUNTS & AUDIT








2. The accounts of every year shall be audited by a Chartered Accountant or a firm of Chartered Accountant who shall be appointed for that purpose by the Trustees and the audited accounts shall be placed at a meeting of the Trustees, which shall be held before the end of the succeeding year.

9. IRREVOCABLE

This Trust is irrevocable.

10. AMALGAMATION

The Trustees may amalgamate the Trust with another Charitable Trust or Institution having similar objects with prior permission of the Charity Commissioner/Court/any other law as may be applicable for the time being.


12. IMMUNITY FOR TRUSTEES


