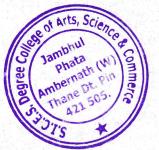

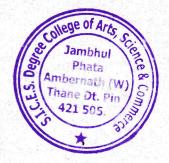

Point No. 11

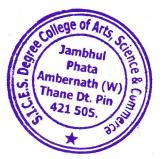
